I also want to especially thank Wayne Swanson, who, as past president of LSLAA, not only served as my mentor and taught me the ropes; he was an active member of the Board. Except for the Treasurer's office, which does not have a term limit, terms for Officers and Directors are two years, and offices are limited to two terms. The following leaders make up the Board. Cindy Nollette – Secretary—has completed one term and is up for re-election.

Mark Doda – Director at Large—has served two terms and will be leaving the Board.

Glenn Gapp – Director at Large—has completed one term and is up for re-election.

Steve Trutna, Vice President – will be serving 2nd year of 2nd term.

Larry Odegard, Director at Large – will be serving 2nd year of 2nd term.

Christine Hobrough, Director at Large – has completed one year of 1st term.

Punky Catlin, Treasurer—no term limits.

Elections 2021—New folks on the docket:

Mark Doda will be leaving the Board due to term limits, and Christine Hobrough has agreed to run for LSLAA president. We are fortunate that we have two individuals who will be running for Director at Large to fill the positions being vacated by Mark and Christine: Jane Amble and Karen Netland. These folks and officers who are up for re-election, Cindy Nollette and Glenn Gapp, will be on our slate of candidates on June 12, but that does not preclude additional nominations, should you like to do so.

Looking ahead to 2022: As you will note, several more Board Members will be "termed out" in 2022, so we need some new people to join the Board next year. PLEASE CONSIDER DOING SO AND LET US KNOW!

We Need Your Membership!

Your membership is greatly needed! Current members, we thank you for your membership and encourage your continued participation. Memberships are especially important to the work we do here on Little Sand Lake. As most of you know, a majority of your dues go toward maintaining our healthy lake, which includes Little Sand Lake's membership in Hubbard County Coalition of Lakes (HCCOLA), support of Minnesota Lakes and Rivers Advocates (MLR), water quality monitoring, and paying for a good portion of AIS Inspection hours at the public lake access.

We have about 150 properties on Little Sand Lake. As of this writing, we have about 75 paid memberships for the current year. (Our "membership year" runs from September 1 - August 31.) Our budget needs require 110 memberships. If you have not paid your dues, there is still time!!

Dues and Donations. As noted above, most of your dues go toward preserving our healthy lake; in addition, a portion of dues goes toward administrative fees such as site fees for our website. For those of you concerned that LSLAA dues go toward social events; they do not – all social events are self-paid by participants, except for a nominal amount spent on the Annual Picnic. Because not all properties join LSLAA, we are very grateful to those of you who have made donations above and beyond the dues amount; LSLAA could not accomplish what it does without those extra funds!

Tax Deductible. LSLAA is a 501(c)3 charitable organization, so your contributions-dues and donations-are tax deductible!

Dues. Dues are \$35 per property. Here are how dues are allocated/used:

•\$15 for Aquatic Invasive Species (AIS) Fund

•\$4 for COLA membership dues

•\$16 for General Fund (Administration, Directories, Memberships, Water test meters, Website, meetings). Dollars from this fund have, upon occasion, been moved to cover shortages in our AIS Fund.

Memorial Donations. Make a memorial donation to Little Sand Lake as a tribute to your loved one. We have a kiosk at the boat launch where we will place a name plate in that person's honor. We recommend a minimum donation of \$50 for a memorial, but a donation of less will not preclude our remembering someone special.

Pay Your Dues Now! To encourage you to get your dues in, all households who have paid dues before our Annual Meeting will be included in and eligible for prize drawings during the meeting.

Custom Dock, Road and Lake Signs

Sign panels are $5\frac{1}{2}$ " high; lettering is $4\frac{1}{2}$ " in height and can be painted in any of several standard colors. The Little Sand Lake logo is also available on signs. Cost is \$45.00 for the first seven letters and \$5.00 additional per letter after seven. Five dollars (\$5.00) of that price is donated to Little Sand AIS Fund. Working to Maintain a Healthy Lake

LSLAA is a member of the Hubbard County Coalition of Lakes (HCCOLA). To be part of this important organization, we pay \$4.00/member. Wayne Swanson has served as Little Sand's HCCOLA representative for the past four years. Below is advice and the status of key issues from HCCOLA:

•HCCOLA holds meetings the last Thursday of every month, except for four months during the winter. Meetings for 2021 started again on April 29th via ZOOM.

•Our public access inspection program is set to go again for 2021. The number of boat inspection hours will be the same as 2020. This is a total of 475 hours inspection hours; LSLAA has paid for 187 of those hours.

•Our lake water testing process starts on May 16, and we will also do two Zebra Mussel tests this year. Speaking of Zebra Mussels, the MN DNR has found Zebra Mussels in Aquarium Moss

Balls sold in pet stores in Minnesota. If you have a Moss Ball DO NOT put it down the drain or throw it into the lake and since ZM will be in the water, boil the wastewater before disposal.

• Also, never toss your aquarium fish into a lake since they are usually not native to our lakes.

Protecting Little Sand Lake

LSLAA undertakes many activities to keep our lake free of AIS and making sure our lake remains one of the cleanest and clearest lakes in Minnesota. These actions address one of the most important goals in LSLAA's mission statement: to provide for "collective action on issues important to all of us."

Below are just a few of the activities that our members/volunteers do to protect this precious resource:

• We are an active member of COLA (Coalition of Lake Associations) and the MN Lakes & Rivers Advocates.

• We provide funding for extra hours (above and beyond the hours the township/county/state provide) to do watercraft inspections for AIS at the public launch.

• We provide educational information to our residents and guests regarding AIS.

• We have developed a Rapid Response Plan in the event of finding any AIS on our lake.

• Volunteers monitor the lake regularly for lake clarity, zebra mussels, AIS vegetation, and DO/ H2O (which is important for our fish population); they also check and maintain stormceptors located near the bridge.

• We also support and provide resources for restoring the shore to make sure the lake stays clean and clear and do roadside pickup several times each summer on CR50.

Healthy Lakes: Resources for Shoreland Management

Hubbard County COLA Tree Orders Due in October

Concerned about your eroding shoreline? The Minnesota Department of Natural Resources (DNR) has an extensive shoreland management program. One topic landowners can learn about is the "buffer zone."



This is an unmowed strip of shoreline that has native vegetation both in the lake and on the land. Many buffer zones extend 25-50 feet onto land, but even 10-15 feet can be very beneficial.

According to the DNR, landowners can improve their buffer zone and enhance their

shoreline by planting grasses and flowering plants that are native to the area to diversify the vegetation, provide food and shelter for animals and even offer a seasonal show of color.

The Hubbard County Coalition of Lake Associations (HC COLA) supports three key programs for landowners. Score Your Shore; Restore Your Shore and Restore The Shore:

•Score Your Shore offers a tool to assess the current situation for your shore.

•Restore Your Shore offers resources to enhance the habitat, reduce runoff and protect the quality of water in and around your property.

•Restore The Shore allows HC COLA members to place orders for high quality, low cost tree, berry, and shrub plants. The order form will be available in September and can be submitted to the LSLAA Restore the Shore coordinator in October with



plants ready for pick up around the first week in May of 2022.

The Hubbard County Soil and Water Conservation District has a Cost-Share Program that enables homeowners to apply to for a grant to share the cost of systems or practices in land management. The Cost-Share Program provides these funds to protect and improve soil and water resources, help reduce erosion, control sediment and improve water quality. Funds can be requested for technical and/or financial assistance for a project. Forestry conversion, shoreland and roadside protection are just some of the projects that may be eligible for the program. Contact the Hubbard County Soil and Conservation Office at 218-732-0121 for more information.

Finally, the *Hubbard County Shoreland Guide to Lake Stewardship* provides helpful information to landowners and visitors.

State Funding Reduced by 20% for AIS Launch Inspections in 2021

Funding for AIS launch inspections was reduced by about 20 percent in 2021 due to COVID impacting state tax revenues. Little Sand Lake has typically had about 475 hours of inspections each season, with the state/county paying for 288 hours; Lake Emma Township paying for 57 hours; and LSLAA paying for 130 hours. The state paid for 57 fewer hours this year.

The LSLAA Board felt it was important to maintain our level of inspections and increased the number of hours paid by LSLAA to 187 hours. This affected our planned budget, as we had to pay about \$1,000 more this year than we have in the past.

Social Committee 2021: Activities are Back!
